

Dear Wenham Residents,

This census form must be completed as accurately as possible to ensure proof of residence, protection of voting rights, and other benefits. Please add **all** persons and animals as requested and remember to sign it. **Signed** forms can be hand delivered or mailed to Town Hall or even be scanned to dbucco@wenhamma.gov.

Registered voters who do not respond to the annual census by June 1st are considered inactive. Inactive voters are required to complete additional forms and show ID at elections in order to vote. Inactive voters who do not respond to the census confirmation mailing and do not vote in two biennial state elections may be deleted from the voting list. If you have any questions or concerns, feel free to call the Town Clerk's office (978-468-5520 x1).

Dog licenses in Wenham are valid from January to December. All dogs over 6 months are mandated to be registered each year. The late fee of an additional \$25 per dog is assessed starting February 1st. Any household with more than 3 dogs must see the Clerk to register as a personal kennel. Information on the second annual "Cutest Dog in Wenham" contest is on the back of the license application.

The Annual Town Meeting is the legislative assembly of Wenham. All registered voters are encouraged to participate. **The 2019 Town Meeting** will be held on Saturday April 6th at 1pm at The Buker School. The warrant for the Town Meeting will be available online and delivered to all households prior to then. The Wenham Village Improvement Society will be hosting the Town Luncheon that is open and free for all residents at noon prior to the meeting.

The Annual Town Election is scheduled for Thursday April 11th at the Town Hall from 7am to 8pm. We will be voting for openings on the Board of Assessors, the Board of Health, the Board of Selectmen, the H-W Board of Library Trustees, the H-W Regional School Committee, the Moderator, the Planning Board, the Water Commission and the Wenham Housing Authority. Information on these positions is available from the Clerk. **To run for any of these positions, nomination papers will be available as of Friday January 12th. Papers are due back to the Clerk's office by March 7th with 21 signatures of registered voters in Wenham.**

If interested in running, please feel free to consult the League of Women Voters' pamphlet "Guide to Running for Office in Hamilton and Wenham" which can be found at the Town Hall and at the Regional Library.

Absentee ballot applications are available to all permanently disabled voters by sending in a request to the Clerk as soon as possible.
